












William P. Rogers #25 – Corinth, Ms.

Thomas "Tom" Edward Meadows, age 58 of Murfreesboro, Tennessee died Sunday, August 1, 2021, at St Thomas Rutherford Hospital. He was born in Charleston, West Virginia and was a son of the late Charles Meadows and Nancy Barber who survives him. He was also preceded in death by a brother, Stephen Wayne Meadows.


In addition to his mother, Tom is survived by his wife of 31 years, Dottie Meadows; children, Kortney Brus (Ashton Darnell) of Spring Hill, TN, Sarah Beth Campbell (Wayne) of Whaleyville, MD, and Sean Thomas Meadows of Murfreesboro; grandchildren, Brayden, Parker, Paisley, Cooper, Letcher; and a host of other loving family and friends.

Tom was a retired history teacher of 20 years, a former professional bass fisherman, and a 20-year member of the Ocean Pines Volunteer Fire Department of which he served as Chief for six of those years.

Tom was a devout teacher of history through reenacting with the 2nd Company Richmond Howitzers, by being a dedicated lifetime member of the Sons of Confederate Veterans; the Mechanized Cavalry, Tennessee Division McLemore Brigade Commander, co-founder of CERT and a strong defender of the Southern Cause.

Visitation will be Wednesday, August 4, 2021, from 2:00 pm until the time of funeral services beginning at 4:00 pm at Woodfin Memorial Chapel, Murfreesboro. Burial will be in the Mountain View Memorial Park in Richwood, West Virginia 2:00 pm Friday, August 6, 2021, under the direction of Simons-Coleman Funeral Home.

Carl Dexter Ford, age 84, passed away on Tuesday, August 3, 2021. Mr. Ford was born March 6, 1937 in Taylorsville, MS, the son of Dexter D. and Alene Robinson Ford. He married Nancy Parker on June 6, 1965. She preceded him in death on February 21, 2020. He earned his Juris Doctor degree from Ole Miss in 1965 and practiced law in Laurel his entire career. He was a life member of the Sons of Confederate Veterans and served as Commander Mississippi Division SCV, 2nd Lt Commander Mississippi Division SCV, Judge Advocate Mississippi Division SCV, and Inspector General Mississippi Division SCV. He was a Charter Member of Camp #227 SCV Jones County Rosin Heels, Camp Commander Jones County Rosin Heels Camp #227 SCV, and Judge Advocate Jones County Rosin Heels Camp #227 SCV. He was also a member of the Jones County Republican Party and the Jones County Bar Associate, a Life Member of the University of Mississippi Alumni Association, and a Veteran of the United States Naval Reserve serving from 1956 through 1964. He was of the Southern Baptist Faith and was a member of Bethlehem Baptist Church. For the last year of Carl's life, he was cared for by Guardian Angels Assisted Living and Southern Care Hospice. They provided comfort and friendship. Mike and Jody Merritt are forever in their debt. There are no surviving family members, but he will live forever in the hearts of Mike and Jody Merritt, Greg Stewart, and George Jaynes. A service will be held at a later date due to Covid-19. There will be a graveside service at Fellowship Cemetery in Taylorsville on Sunday, August 8, 2021 at 2 p.m. Dr. Cary Kimbrell will officiate.

Social Media Policy

Social Media is a term that describes the engagement in internet-based social platforms that are visible to others. Social media tools allow for the creation and exchange of user-generated content. All social media is trackable, traceable, and discoverable. These networks include (but are not limited to):

- Audio/video sharing (podcasting, TikTok, YouTube, Webinars, Vimeo, etc.)
- Blogs and blog comments
- Commenting on news stories and other platforms online
- Document sharing (Dropbox, Scribd, Slideshare, etc.)
- Gaming sites
- Geotaging and review (Foursquare, Google Reviews, Nextdoor, TripAdvisor, etc.)
- Information sharing (Chat Rooms, Listservs, Forums, Message Boards, etc.)
- Micro-blogs (Twitter)
- Photo sharing (Instagram, Snapchat, Flickr, Pinterest, Photobucket, Shutterfly, etc.)

• Professional and social networks, and publishing platforms (Facebook, Forbes, Tumblr, WhatsApp, LinkedIn, Skype, etc.)

• Social bookmarking (Pocket, Reddit, etc.)

New platforms and applications for electronic devices (mobile, TV, PDA's, etc.) are being launched regularly. All of these increase the users' virtual footprint, introduce new business development, marketing, and public relation opportunities, and add to the amount of trackable, traceable, and discoverable information online. The Sons of Confederate Veterans believe the use of social media can support the transfer of information within membership, assist with recruitment and retention and promote the organization. We are aware of, and understand, how social media can affect relationships with membership, the media and those outside of our organization. We also understand social media is often used personally and not exclusively for the business of the organization. The Sons of Confederate Veterans Social Media Policy provides guidelines for online behavior by members of our organization. As new tools are introduced, and new challenges emerge, the Sons of Confederate Veterans Social Media Policy will evolve to reflect those changes.

Individual Profiles

You are personally responsible for any online activity you conduct. We respect your right to privacy and free speech as they apply to online activity conducted on your personal social network and email address. However, what you publish on such personal sites should never be attributed to the Sons of Confederate Veterans and should not appear to be endorsed by or originated from the Sons of Confederate Veterans. If you choose to list your affiliation on a social network, then you should regard all communication on that network as you would in a professional network. Online lives are ultimately linked, whether or not you choose to mention the organization in your personal online networking activity.

Content and Language

- Never disclose or use proprietary, privileged, or confidential information in any form on online media.
- Be respectful of personal privacy.
- Obey the law. Do not post any information or conduct any online activity that may violate applicable local, state, or federal laws or regulations.
- Do not post anything using the Sons of Confederate Veterans logos, trademarks, flags, etc. with racists or inflammatory remarks.

• Be wary of hostile communications. If a reporter, blogger or any other online influencer posts a statement with which you disagree, and you feel a comment is warranted, be very careful in your use of words. Vulgar or derogatory language should be avoided at all cost. In some states, online harassment is a misdemeanor or a felony.

• Responding to the media requires approval. If you are contacted directly by a journalist regarding issues pertaining to the Sons of Confederate Veterans, bring the inquiry to the attention of an officer. Nondiscrimination and Anti-Racism The Sons of Confederate Veterans will not tolerate discrimination and racism. Any online discourse in violation of our nondiscrimination and anti-racism policy, including shared content online, maybe be cause for disciplinary action up to and including expulsion.

Consequences for Violating Social Media Policy

If anyone is found to have violated the Sons of Confederate Veterans Social Media Policy, appropriate disciplinary action up to and including expulsion may be taken.
